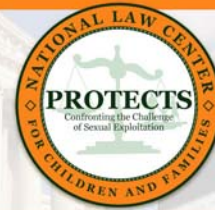

“Take 25”-Make Time to Talk about Child Safety

Between 1979 and 1981, a series of high-profile missing children cases became national headlines. Three such cases contributed to the shock of the nation’s consciousness by bringing attention to the seriousness of child victimization and forever changing the way law enforcement agencies responded to reports of missing children.

On May 25, 1979, 6-year-old Etan Patz disappeared from a New York City street on his way to school. For almost three years, from 1979 to 1981, national media attention was focused on Atlanta, Georgia, where the bodies of young boys and girls were discovered along waterways. By the time a suspect was arrested and identified in 1981, 29 children had been murdered. On July 27, 1981, 6-year-old Adam Walsh disappeared from a Florida shopping mall. His parents, John and Revé Walsh, immediately turned to law-enforcement agencies to help find their son.

The tragedies of these children and others exposed a fundamental flaw. There was no coordinated effort between federal, state, and local law enforcement; no national response system in place; and no central resource to help searching families. In response, the National Center for Missing & Exploited Children (NCMEC) was created in 1984 under federal mandate as a private, nonprofit 501(c)(3) organization to provide services for families and professionals in the prevention of abducted, endangered, and sexually exploited children. One year earlier, President Ronald Reagan proclaimed May 25, the day that Etan Patz disappeared, as National Missing Children’s Day. Since then, each administration has honored this day as an annual reminder to the nation to renew efforts to reunite missing children with their families and to make child protection a national priority.

To commemorate this day, NCMEC launched the Take 25 campaign, a national grassroots initiative encouraging parents, guardians, and others to take 25 minutes out of their day to talk to children about safety. With a focus on prevention, Take 25 provides communities with free safety resources including safety tips, conversation starters, child ID kits, and more.

To better reach children and families with this message, NCMEC has partnered with more than 100 local and national organizations, including the National Law Center for Children and Families, to host Take 25 events across the United States and abroad. To help facilitate these events, Take 25 provides event organizers with sample outreach materials, planning resources, and talking points, free of charge.

The Take 25 campaign has grown tremendously since its inception in 2007, when 375 events were hosted nationwide. In 2009, 1,335 child safety events were hosted in 475 communities across the United States and Canada. As a result of these events, tens of thousands of children and families have been provided with invaluable child safety information.

“I believe that in order for children to be safe, they need to have an open line of communication with a safe adult,” said event organizer Kristi Baker, Executive Director of the Southwest Washington Child Care Consortium. “The Take 25 philosophy exemplifies the significance of time and preventive measures to help children stay safe. Thanks to the Take 25 campaign we have the materials to share with our families!”

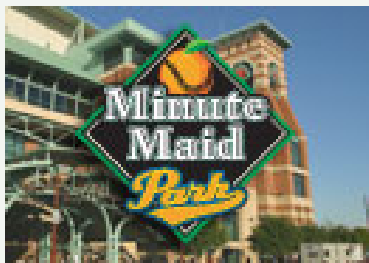

Updates from the Battle Against Child Exploitation

FORT WYLIE MAN SENTENCED FOR POSSESSION OF CHILD PONOGRAPHY

Columbia, SC, November 13, 2009:

A report issued by the United States Attorney's office of the South Carolina states that Jord Hampton Jordan IV, 26, has been charged with a child pornography offense on November 13, 2009. The defendant faces 80 months imprisonment as well as federal supervision for the rest of his life. In addition, Jord Hampton Jordan IV is required to register as a sex offender near his home and work.

Jord Hampton Jordan IV admitted that he possessed child pornography and turned his computer over to federal authorities which then located five child pornography videos and numerous images.

The case was investigated by Assistant United States Attorney Dean A. Eichelberger of Columbia as well as by agents of the United States Immigration and Customs Enforcement.

COLUMBIA MAN CHARGED FOR ATTEMPT TO ARRANGE SEX WITH MINOR

Columbia, SC, November 23, 2009:

The United States attorney's office of South Carolina released a report of a 56 year old man being arrested for possession of child pornography. Dennis Michael Gallipeau has been sentenced to 97 months in prison and lifetime supervision upon his release. In addition, he is required to register as a sex offender in the state of South Carolina.

Gallipeau contacted a police officer who pretended to be a mother of a younger girl. The defendant made plans with the undercover agent to travel to Detroit to engage in sexual activities with the child. Federal agents confronted Gallipeau and examined his home where they found disturbing images of child pornography on his computer. This led to the prosecution and sentencing of the defendant.

This case was handled by Assistant United States Attorney Dean A. Eichelberger of Columbia office in cooperation with the agents of the Federal Bureau of Investigations.

LORIS MAN SENTENCED TO 11 YEARS IN PRISON FOR CHILD PONOGRAPHY

Loris, SC, October 23, 2009:

The United States Attorney offices reports that Charles A. Hardee, 45, was sentence to 11 years in federal prison for possession of child pornography. The defendant will also be supervised for three years upon his release.

Agents traced emails from a New York man's computer who was suspected of trading child pornography to Hardee's residence in South Carolina. After completing a detailed examination agents found two computers and one thumb drive containing images of child pornography. In addition, evidence was found which revealed that Hardee has traded child pornography as well as entered chat rooms seeking mothers who are willing to allow their children to have sexual activities with the defendant.

This case was investigated by the agents of U.S Immigration and Customs Enforcement and Assistant United States Attorney William E. Day, II, of Florence office handled the case.

MAN CHARGED FOR ATTEMPT TO ENGAGE IN SEXUAL CONDUCT WITH MINOR

Benton, IL, January 7, 2010:

53 year old Paul R. Bradley was charged for travelling from Oregon to Illinois to engage in illicit sexual conduct with a minor. Therefore, the defendant was sentenced to 20 years in prison, fined \$500 and placed on a 10 year supervised release by the State District court in Benton, Illinois.

This case was investigated by the Federal Bureau of Investigation Southern Illinois Cyber Crimes Task Force, the Illinois Attorney General's Office Crimes Against Children Task Force, the Wabash County Sheriff's Office, the Mt. Carmel, IL Police Department,

The Wabash County State's Attorney's Office, and other state and local law enforcement agencies and was prosecuted by Assistant United States Attorney George A. Norwood.

FEDERAL JUDGE PUSHES FOR RESTITUTION IN CHILD PORNOGRAPHY CASE

St. Paul, MN, January 5, 2010:

Federal Judge Patrick Schlitz queried federal prosecutors on their position on restitution of a child pornography victim.

This case involved a civil proceeding where a child pornography victim demanded damages in court. Under the Adam Walsh Act enacted in 2006, a part of that law provided the ability of victims of child pornography to file civil suits to recover financial damages from those who victimize children.

The Judge requested the local federal prosecutor to explain their position on the issue. The Court said,

"Given the clear congressional mandate that those convicted of child-pornography offenses pay restitution to their victims, the court will no longer accept silence from the government when an identified victim of a child-pornography offense seeks restitution," Schlitz wrote.

The government had until January 29 to file their response to the Court.

These cases by child pornography victims are being reported in the media. While financial damages may address some of the victim's harm, the impact on the policy of eradicating child pornography can be significant. The National Law Center will continue to monitor these cases and encourages prosecutors to look into restitution incases which merit victim awards.

Executive Director presents “Online Investigation” Webinar offered by Vere Software

On January 21, 2010, Richard Whidden, Executive Director and Senior Counsel of the National Law Center for Children and Families, was the instructor of the fifth free webinar series, “Online Investigation,” offered by Vere Software. This presentation provided an overview of recent court rulings involving child exploitation internet crimes. In addition, he presented the *Comprehensive Drug Testing* case concerning “forensic procedures relative to search and seizure of electronically stored evidence.”



“Much of the case law on electronic evidence comes from child pornography cases because those are what prosecutors take on. So investigators of many other crimes can take important information away from these cases,” Mr. Whidden said.

The objective of the webinar was an effort to educate and inform investigators on what particular evidence may be substantial to provide prosecutors for building a strong case.
